## MESSAGE FROM <u>THE</u> CEO

Bismillah Arrahman Arrahim. All praise is due to Allah (SWT), who says in the Glorious [Quran 5:32], "Whoever saves a life, it is as if (s)he saved the whole humanity". Peace and blessings on His Prophet Muhammad (PBUH), of whom Allah (SWT) says: "We have only sent you as a mercy to the whole of creation." [Quran 21:107].

Building sustainability, equality, equity and every other thing we do in MAA are inspired by our values of trustworthiness, efficiency, sustainability, impact, and faith.

Dear Stakeholders of MAA, I am pleased to present to you the annual report of 2018.

In 2018, MAA continued its solid year-toyear performance at every front, despite the challenges faced during the past year, which I am going to share with you, driven from our transparency commitment to you. MAA has successfully passed all audits conducted by different government and non-government agencies. This includes the annual independent financial auditing, a random audit conducted by both the Australian Charities and Not-for-profit Commission (ACNC) and the Department of Foreign Affairs and Trade (DFAT).

While we are here at the compliance front, I am proud to mention that MAA continued to be a top signatory of the Australian Council For International Aid (ACFID), continued to be an accredited member of DFAT and the ACNC.

### Why MAA takes compliance and risk management seriously?

It is MAA's responsibility to ensure the donations that MAA is entrusted with, are spent according to their charitable purposes, respecting the wish of the donors. This requires MAA to put advanced design, monitoring, evaluation, reporting, accounting, technology, and risk management systems in place. This gives you, as our stakeholder, the peace of mind that your donations are well and rightfully managed.

Another reason is that we at MAA aim to increase the impact of every dollar of your donation, making it more than a dollar in value and impact. Therefore, any extra admin expenses become, in fact, an investment to make the other dollar much more impactful.

At the projects front, MAA continued its support of sustainable development projects, especially projects that are centered around Permaculture, health, education, and renewable clean and ethical energy. MAA grew the support of these programs to ~AU\$3.95M in 2018, up from ~AU\$3.8M in 2017. However, our recognised development expenditure grew to ~AU\$6.7M. This demonstrates MAA's commitment to its clear Vision and Mission, where sustainable development sits in the heart.

Despite the financial stresses that the world is experiencing in general, and the increased number of NGOs in Australia MAA continued its revenue growth to ~AU\$15.3M.

As MAA puts the safety of our donors and stakeholders first, equally putting the longer term, higher-impact sustainable development projects, there was a little price to pay, which is the increase of Admin & Accountability % from 6.6% in 2017 to

~8.6% in 2018. The increase of the Admin & Accountability % was an investment to ensure MAA's risk management, compliance, accountability and projects' impact stay at a world-class level for the benefit of all of MAA's beneficiaries and stakeholders. Although the Admin & Accountability % increased, yet the impact of the projects' dollar has increased even more. That is worthy to note for sure!

We look forward to your continued support for even stronger and more impactful 2019.



#### Australian Charity and not-for-profit Commission

As a registered charity MAA complies with the ACNC (Australian Charity and not-for-profit Commission) Act 2012. We have also received the ACNC "Registered Charity Tick" which serves as a reassurance to our donors and stakeholders that MAA is transparent and accountable.

Workplace Laws: MAA is committed to complying with all workplace laws. To ensure that all those who work with us are treated fairly and with respect, we are compliant with:

- 1. Fair Work Act 2009
- 2. Work Place Gender Equality Act 2012
- 3. Privacy Act 1988

Workplace practices and internal policies are regularly reviewed to ensure compliance.



MAA is a full member of the Australian Council for International Development (ACFID) and therefore, a signatory of the ACFID Code of Conduct. As a result, we are committed to adhering towards a high standard of accountability and transparency. Respect, protection of human rights, sustainability and fair, continuous improvement form the foundations of MAA's work. The NGO sector is a dynamic and often challenging environment to work in. MAA International considers the safety and security of employees and volunteers as a top priority, which is why we have been partners with International SOS (Intl.SOS) since 2016. Intl.SOS provides first class medical and security assistance 24/7, ensuring travellers feel safe and healthy when carrying out core business activities internationally.



Department of Foreign Affairs and Trade

In 2017, MAA became the first and only Islamic NGO to be accredited by the Australian Government's Department of Foreign Affairs & Trade (DFAT).

The DFAT accreditation rigorously assessed our governance, program management capacity, policies, risk, and partner management.

Among other benefits, the accreditation means that MAA International is now also eligible to receive funding through the Australian NGO Cooperation Program (ANCP).



Internal control & governance are integral parts of our day-to-day operations. Policies, Processes, Key Performance Indicators and Systems are in place to ensure effective governance.

Ongoing monitoring, reporting and internal controls are undertaken and reviewed by the executive team to ensure all operations are aligned to achieve the charity's purpose. These include the following: -

- The **constitution** represents the overarching rules of the organisation. The constitution contains all the necessary rules reflecting the public benevolent institution (PBI) nature of the organisation
- A **strategic plan**, which includes an annual operating plan and budget.
- **Budgeting, delegation** of day-to-day management authority, and **segregation of duties**.
- The identification and management of risks.

The Executive Board is integral to all the above-mentioned internal control processes.



Everyone at MAA takes compliance seriously.

Since the current executive team took over control of MAA back in mid-2012, MAA never missed a compliance activity including meeting the ACNC, ATO, ACFID, State & Federal governments, and financial auditing compliance requirements.

We have a dedicated team who uphold, implement  $\vartheta$  adhere to both, Islamic values and Australian legislation. These values extend to our field partners.

Our CEO Imam Hassan Elsetohy is qualified in Engineering, Management, Sustainable Systems Design and Islamic Studies. He has many years of experience working in both the corporate and social sectors.

MAA developed what can be considered the world's first systems that conform to both the Australian legislations, Islamic regulation and the ethos of donation management.

These systems are implemented from the ground up in our technology and corporate processes. They are designed to ensure all funds received and disbursed are in full compliance.





Doing the right thing... Right!

It is an essential part of our great religion, Islam, to not only "**do the right thing**" but to do it "**right**".

This means that all our actions are **accountable**, **transparent** and **professional**. We work hard to achieve **excellence** and above all, **sincerity** in everything we do.

We continually endeavour to improve the impact of the humanitarian aid we provide around the globe. We seek new and innovative methods and try to establish strong humanitarian relationships to increase the scope of our projects. MAA is continually developing new strategies to reduce operating costs.

Ultimately, we ensure that all stakeholders obtain the maximum impact from the work we undertake.



MAA has a strong ethos when it comes to diversity. Our staff comes from **diverse cultural backgrounds** with highly honed skill sets applicable to all parts/ aspects of operations. We speak over **6 languages** at MAA!

MAA also has an equitable staff gender balance with approximately 40% of our staff being female.

Since 1989, MAA has operated in **over 50 countries** without discrimination on the basis of colour, race, ethnic background, gender or religion.

### MAA <u>RISK</u> MANAGMENT

MAA takes risk-management seriously! Early identification and management of risk is necessary for MAA to continue delivering effective aid in an increasingly complex, challenging and changing environment. MAA adopts world-class risk management methodologies and frameworks, including the guidelines issued by the Department of Foreign Affairs and Trade (DFAT – Aid-Programming Guide, version March 2017) for Risk Management.

Risk management involves thinking about, understanding, regularly monitoring risks, and taking mitigation actions when necessary. It covers due diligence of delivery partners, assessments of partner government financial systems, fraud control, anti-corruption efforts, and child protection and safeguards.

MAA manages risks at the strategic, operational and managerial levels.


#### What Is Aid Risk Management?

Aid risk management is a process for ensuring that uncertainty does not detract from the delivery of the aid program's objectives. It is an ongoing process that involves:

- identifying and analysing potential risks and opportunities throughout the aid management cycle
- developing proportionate and defensible strategies to balance risk and benefit, and enable sound decisions about whether to start, continue, modify or conclude an aid investment
- monitoring risk—including through internal and external discussions—and updating risk registers; and
- when necessary, escalating risk to the attention of higher decision-makers or forums.

Effective risk management is about being open to, and actively managing, an acceptable level of risk in order to achieve effective development outcomes.

Aid risk management covers due diligence assessment of delivery partners; evaluations of partner governments' financial systems; fraud control and anti-corruption efforts; and safeguards (including environment, child protection, displacement and resettlement).



#### MAA has adopted the following DFAT Safeguards Compliance Flowchart:

## CHILD PROTECTION

In the course of executing aid projects with different partners, contact with children can occur in relation to a broad range of aid projects. While it may not be possible to eliminate all risks related to child exploitation, endangerment and abuse, careful planning and risk management can reduce these concerns considerably.

Safeguarding children refers to the broad obligation of officers and partners to ensure MAA programmes and operations do not expose children to the risk of abuse and exploitation, and that any concerns about children's safety within the communities MAA and partners work in are appropriately reported. Direct and indirect risks to children must be considered as part of the design and implementation phases in MAA projects.




MAA believes that everyone should have access to clean water. This underpins all other aspects of development. Unfortunately, more than a billion people lack access to safe drinking water today.

#### **Operational Ethos:**


Our Water and Sanitation programmes incorporate building infrastructure, improving sanitation, and developing hygiene awareness.
















## ORPHAN AID

Our Orphan Aid programme provides quality assistance to orphans regardless of their race, creed, or gender. Every effort is made to ensure that they receive the basic necessities of life.


## HEALTH & MEDICAL


















## SUSTAINABLE DEVELOPMENT & AGRICULTURE


#### **Operational Ethos:**

# RAMADAN

MAA's Ramadan programme has evolved over the years to deliver more than just essential Food Aid to poor and needy people around the world during the blessed month of fasting. MAA has now focussed its efforts on expanding the Ramadan distribution to include Income Generating Gifts to beneficiaries to help them break the cycle of poverty.

The Ramadan programme covers families and individuals who are socially, financially, economically, and culturally disadvantaged and distressed. Other than focusing on the poor and needy, we also focus on widows, orphans, the disabled, destitute, and the elderly.
















# QURBAN

Qurban is MAA's primary humanitarian Food Aid programme. Traditionally, livestock is sacrificed at the point of distribution and fresh meat is given to the beneficiaries immediately. However, MAA also packs Qurban meat in sustainable, long-shelf-life packages that can be distributed where electricity and refrigeration are absent.


Our focus in delivering Qurban Food Aid are the most vulnerable people that include widows, orphans, the elderly, internally displaced people, refugees and the poor.

# FOOD AID

Despite the best efforts of international aid agencies, the global food crisis continues to spiral out of control, especially in recent years. The direct impact of lack of food on the poor and needy is tremendous and this is the main reason why the food crisis is at the forefront of our agenda in MAA..

## **Operational Ethos:**

MAA is committed to tackling the food crisis and its causes, with the aim of providing people and their communities' access to basic food and aim to make them self-sufficient. We also ensure that Food Aid is culturally appropriate to each country where distribution takes places.



# SHELTER & HOUSING

Every human being needs a decent place to live. Without the safety of a home, poverty and its effects damage all aspects of a family, the community, and their overall prosperity.

When disaster strikes, whether natural or manmade, and people are left on the streets with no place to call home, our first response is to accommodate people in Emergency Shelters but we are also committed to more long-term solutions.

## **Operational Ethos:**

MAA builds both Emergency Shelters and Permanent Housing to address both shortterm and long-term needs of those affected by disasters. We also undertake rebuilding of homes wherever possible.





MAA conducts Aqeeqah or General Sacrifice in the neediest areas globally.

It is a Sunnah of the Prophet Muhammad (PBUH) to perform Aqeeqah for the child by slaughtering two goats or sheep for a boy and one sheep or goat for a girl, usually on the seventh day after the child is born.

Every year, thanks to this noble activity, thousands of beneficiaries around the world are able to enjoy a nutritious meal that is a change from their usual diet.


# **EDUCATION & SKILLS TRAINING**

Millions of children around the world do not have access to quality education due to the prohibitive costs. With their families struggling to even meet their essential needs like food and shelter, and with many children required to work to help support their families, it is impossible for them to seek and acquire an education.

Many children who do attend school receive an inadequate education because of poorly trained or underpaid teachers, overcrowded classrooms, or lack of basic education tools and books.

MAA strives to educate and up skill people and the communities they live in by providing them essential education and vocational training with the aim to make them self-sustaining and financially independent.

## CASE STUDY 1 INCOME GENERATING GIFT DHAKA, BANGLADESH

## **THE SITUATION**

This is Sabina, a young woman staying in a tiny house in a riverside slum in Dhaka, Bangladesh.

Her tiny house of 2 rooms is inhabited by herself and husband, siblings, and her parents – a total of 7 people. Her husband is a day labourer, her father also works in a factory as labourer and her mother supports her by selling goods and making rice cakes near the shop.



## THE RESULT

Sabina started a small shop 18 months ago but her inventory and sales income was not enough to manage a family of 7 people. MAA, through our fundraising partner AMIA's generous donation, is supporting Sabina's shop with stock on an on-going basis which has helped them to increase their income.

Now Sabina earns a healthy profit from every day sales and this goes a long way in supporting her poor family. She has the dream of expanding the business in future so they can live in a more comfortable manner.



# CASE STUDY 2 INCOME GENERATING GIFT AKKAR, LEBANON

# THE SITUATION

Zainah Hussein is a 32 year old widow in Akkar, Lebanon who is raising 4 young children on her own in a small house. Her husband died a few years ago, leaving her shocked and helpless, and life has been a struggle since then. With neither the employment opportunities for her to make ends meet, nor a proper source of income, her young, school-aged children are deprived of many essential needs, adding to her worries.

## THE RESULT

As part of our Livelihood Projects, MAA gave her a Life-changing Gift of a Breeding Cow to help her out. We also equipped her with feed for the animal and gave her basic training to look after it. After 2 weeks it started producing milk, which she is now able to sell in Akkar. Zainab also makes cheese, yogurts and other dairy food which she uses to nourish her young children and is now able to make a steady income selling these products.

Thanks to MAA's Life Changing Gift, Zainab is now able to support her family for their basic needs and hopes to put her life back together bit by bit.




# FINANCIAL REPORTING



Extra stringent compliance requirements that were placed on our field partners resulted in slowing down some project disbursements. However, these disbursements are in the pirpline.

**Programmes Disbursement Ratio:** Defined as the total amount spent on developmental and aid projects, presented as a percentage of the total received programme donations. It includes both Programme Support and Programme Direct disbursements. **Programmes Support Ratio**: Defined as the total amount spent on projects support activities to ensure success and quality of the projects. The activities include project monitoring, evaluation, and management and is presented as a percentage of the total received programme donations.


